* Transfer certificate should be issued only under the signatures of the regular Principal/ Vice Principal and it should be countersigned by an officer not below the rank of District Inspector of Schools/ Deputy Director of Education/ Educational Officer of the Educational Deptt. of the State/ Union Territory concerned. In case of a student migrating from one CBSE affiliated school to another CBSE affiliated school the transfer certificate of previous school of such a student may be countersigned by the Regional Officer of the Board or the Assist. Commissioner of the KBS or the Deputy Director, Navodaya Vidyalaya Samithi in India or an officer of the Board of the Head quarters and by the First Secretary/ Attaché/ Cultural Attaché or an equivalent officer of the Embassy/ High Commission of India in the concerned country in respect of students studying in an affiliated school of the CBSE situated outside the country and the student shall not be admitted to a school without a counter signature.
